For the consideration outlined Tag Application Service Application Order Form, I, being the hunter identified on the Hunter Information portion of the TAG Application Service Application Order Form (sometimes referred to in this agreement as "I", "me" or "Client") desire to employ Worldwide Trophy Adventures Application Service, LLC, a Michigan limited liability company ("WTA") as my agent (and as necessary, my personal representative) to process my big game applications, licenses and permits and any required purchases associated with the application process. The Tag Application Service Application Order Form together with these "Tag Application Service Terms and Conditions" shall be collectively referred to as the "Agreement." My consent to these Tag Application Service Terms and Conditions is a material inducement to WTA to perform the services outlined elsewhere in this Agreement.

By signing or submitting the Tag Application Service Order Form, I represent and warrant that I am at least 18 years of age and agree to all of the items otherwise set forth in the Agreement. I hereby authorize WTA to perform any task associated with the process of applying for my big game applications and to pay any and all fees associated with such applications, licenses or permits, each on my behalf. I represent and warrant that all the information I have provided to WTA, verbal and written, including the statements on this Agreement, are true, complete and correct. I hereby authorize any State, Federal or Tribal Wildlife Agency to make additional inquiries to verify my eligibility to apply for and obtain any permit(s) and/or license(s). I hereby authorize WTA to disclose any information contained in this Agreement or on the application to such State Federal or Tribal Wildlife Agency in connection with my applications. I warrant that I am eligible to apply for and acquire all of the license(s) or permit(s) selected on any application form I submit to WTA. I understand that WTA will not issue a refund of application or license fees in the event that my eligibility to hunt or possess a weapon changes. I will indemnify and hold WTA harmless from any damages or fees incurred by WTA, if I apply (on my own behalf) for the same permit(s), or license(s) on an application order form and there are specific State, Federal, and Tribal laws pertaining to or prohibiting applying for any permit or license more than once. I will not apply for any permit or license of any kind, in any state or region in which I have directed WTA to perform services for me, including but not limited to any application for or purchase of permit(s) or license(s).

TERMS AND CONDITIONS

Notwithstanding anything else in this Agreement, I understand that I shall be responsible for any and all fees incurred by WTA arising out of or related to the services provided by WTA on my behalf, including any application fees, processing fees, license fees or other similar charges. I agree to reimburse WTA for any and all expenses incurred by WTA in connection with any successful or unsuccessful drawing. I authorize WTA to collect any and all credits or fees associated with any services included in this Agreement, and I represent and warrant that I will pay for the costs of the collection process and for any amounts due to WTA. I hereby grant WTA the option to hold any permit(s), license(s) or voucher(s) in its possession as security and additional collateral for the enforcement of any part of this Agreement. I understand that WTA may charge my credit card for all associated reimbursement(s), payment(s), fee(s), and, refund check(s) arising out of or related to the services performed by WTA on my behalf. I hereby consent to all such charges.

I understand and agree that WTA has no influence on any State, Federal, or Tribal Agency or any any draw process, including any physical or electronic draw. I specifically give WTA permission and desire that WTA to endorse any funds returned to them, in my name, for the reimbursement of credit WTA extended on my behalf in connection with this Agreement. I hereby release WTA from any and all damages I may sustain, which are not caused by the gross negligence of WTA.

CREDIT CARD

I understand and agree that I am responsible to maintain at least one credit card with sufficient credit available for any action associated with this Agreement. I agree and understand that WTA recommends that I maintain a separate credit card or a back-up credit card, which may help with any credit card "glitches" that are out of the control of WTA. The grant of power herein contained is given and granted in order to facilitate the application process on behalf of Client and the attorney-in-fact appointed hereby shall have the power to (i) execute any hunting or fishing license, permit applications and endorsements of such licenses and (ii) transfer funds as authorized and described in this Agreement. My attorney-in-fact hereby accepts this appointment subject to its terms and agrees to act and perform as he, in his best discretion, deems advisable, and I affirm and ratify all acts so undertaken. MISCELLANEOUS

The terms and conditions of this Agreement shall be governed, construed, interpreted and enforced in accordance with the domestic laws of the State of Michigan. A waiver by either party of any breach or failure to comply with any provision of this Agreement by the other party shall not be construed as or constitute a continuing waiver of such provision or a waiver of any other breach of or failure to comply with any other provision of this Agreement. If any provision of this Agreement is held, in whole or in part, to be invalid, the remainder of such provision and this Agreement shall remain in full force and effect, with the offensive term or condition being stricken only to the extent necessary to comply with any conflicting law. This Agreement constitutes the entire agreement between the parties with respect to the subject matter of this Agreement. This Agreement may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which shall constitute one and the same Agreement.
